

## Privacy Policy

Enso Group is committed to safeguarding the privacy of our website visitors; this policy sets out how we will treat your personal information.

### What information do we collect?

We may collect, store and use the following kinds of personal data:

- a. information about your computer and about your visits to and use of this website (including your IP address, geographical location, browser type, referral source, length of visit and number of page views);
- b. information relating to any transactions carried out between you and us on or in relation to this website, including information relating to any purchases you make of our goods or services;
- c. information that you provide to us for the purpose of registering with us (including your name, email address, postcode, telephone number);
- d. information that you provide to us for the purpose of subscribing to our website services, email notifications and/or newsletters (including your email address);
- e. any other information that you choose to send to us;

### Cookies

A cookie consists of information sent by a web server to a web browser, and stored by the browser. The information is then sent back to the server each time the browser requests a page from the server. This enables the web server to identify and track the web browser.

We may use both “session” cookies and “persistent” cookies on the website. We will use the session cookies to: keep track of you whilst you navigate the website; and other uses.

We will use the persistent cookies to: enable our website to recognise you when you visit; and other uses.

Session cookies will be deleted from your computer when you close your browser. Persistent cookies will remain stored on your computer until deleted, or until they reach a specified expiry date.

We use Google Analytics to analyse the use of this website. Google Analytics generates statistical and other information about website use by means of cookies, which are stored on users' computers. The information generated relating to our website is used to create reports about the use of the website. Google will store this information. Our advertisers/payment services providers may also send you cookies.

Most browsers allow you to refuse to accept cookies. (For example, in Internet Explorer you can refuse all cookies by clicking "Tools", "Internet Options", "Privacy", and selecting "Block all cookies" using the sliding selector.) This will, however, have a negative impact upon the usability of many websites, including this one.

## Using your personal data

Personal data submitted on this website will be used for the purposes specified in this privacy policy or in relevant parts of the website. We take your privacy and the security of your personal information extremely seriously, and we comply with the requirements of the Data Protection Act 1998.

We may use your personal information to:

- a. administer the website;
- b. improve your browsing experience by personalising the website;

- c. enable your use of the services available on the website;
- d. send you general (non-marketing) commercial communications;
- e. send you email notifications which you have specifically requested;
- f. send to you our newsletter and other marketing communications relating to our business which we think may be of interest to you by post or, where you have specifically agreed to this, by email or similar technology (you can inform us at any time if you no longer require marketing communications);
- g. provide third parties with statistical information about our users – but this information will not be used to identify any individual user;
- h. deal with enquiries and complaints made by or about you relating to the website;

Where you submit personal information for publication on our website, we will publish and otherwise use that information in accordance with the license you grant to us. We will not without your express consent provide your personal information to any third parties for the purpose of direct marketing.

e. International data transfers

Information that we collect may be stored and processed in and transferred between any of the countries in which we operate in order to enable us to use the information in accordance with this privacy policy.

Information which you provide may be transferred to countries which do not have data protection laws equivalent to those in force in the European Economic Area. In addition, personal information that you submit for publication on the website] will be published on the internet and may be available, via the internet, around the world.

You expressly agree to such transfers of personal information.

### **Security of your personal data**

We will take reasonable technical and organisational precautions to prevent the loss, misuse or alteration of your personal information. Of course, data transmission over the internet is inherently insecure, and we cannot guarantee the security of data sent over the internet. You are responsible for keeping your password and user details confidential. We will not ask you for your password.
